Pursuant to a letter of agreement dated February 16, 2023, and signed by Frank Gilbo, Treasurer of the New York State Correctional Officers & Police Benevolent Association, Inc., hereinafter referred to as "NYSCOPBA", the American Arbitration Association, hereinafter referred to as the "Administrator", agreed to conduct an Election of Officers.

Ballots were mailed to eligible voters on Friday, August 4, 2023, as follows:

NYSCOPBA provided the Administrator with a list of persons who were eligible to vote. To be counted, ballots had to be received by the Administrator no later than 5:00 PM on Wednesday, September 20, 2023. The administrator received envelopes prior to the reception deadline as follows:

NOID = Identifying information for the voter was not visible on the envelope and their eligibility could not be verified

NOL = Member was not on the provided eligibility list and was deemed ineligible to vote by the Election Committee

DUP = Two ballot packets were mailed to 64 members in the initial mailing due to a printing error. The original ballot was counted.

CR = Member returned contract referendum ballot in the officer election envelope.

The counting of ballots took place at the office of the Administrator, located at 120 Broadway, Concourse Level, New York, NY on Thursday, September 21, 2023, at 10:00 AM. The counting of ballots was live streamed for virtual observation.
