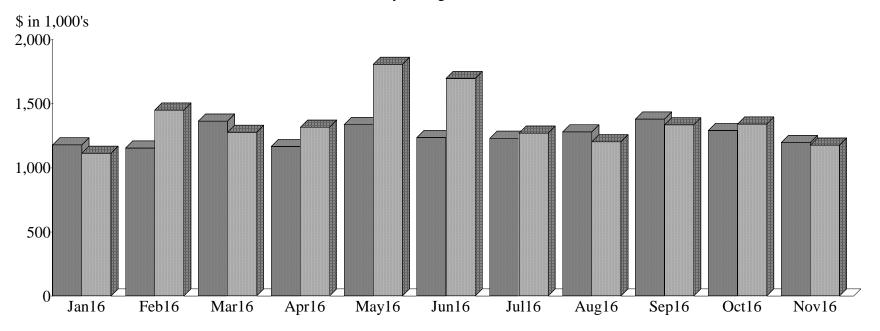

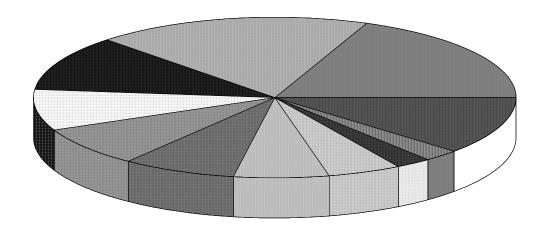

Income and Expense by Month January through November 2016





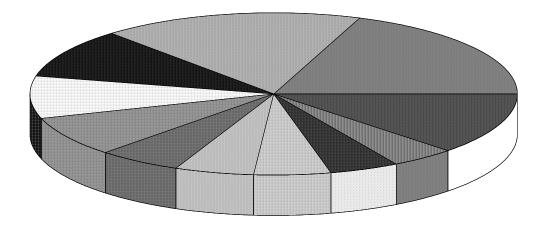
