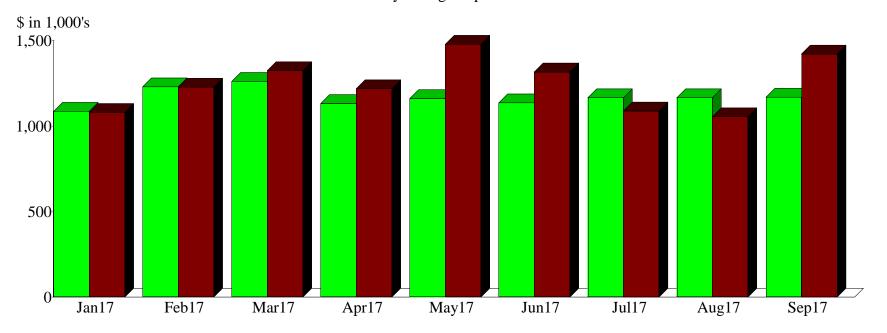

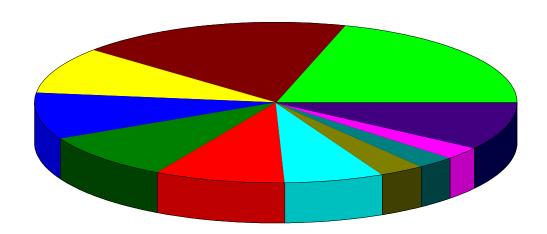

Income and Expense by Month January through September 2017



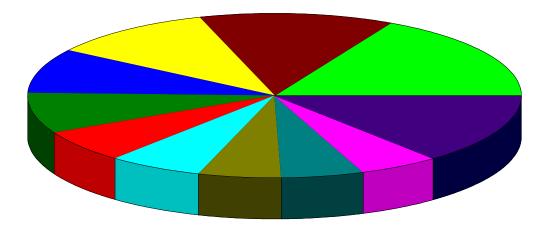
