A Green Haven Officer sustained damage to his personal vehicle while in route to the facility from outside hospital detail. The state claims that they are not responsible for the damage and will not pay. The contract provides for \$350 for damage, but that doesn't even cover most people's deductible. We should look into other avenues for reimbursement.

The massive storm that affected our area this past week knocked out the power, phone lines and internet of the Mid-Hudson Office for several days. We are back up and running.

Inmate on inmate fights with weapons at Otisville CF on May 2nd. Otisville staff handled the situation well. They are finding weapons, drugs and other contraband in the facility.

A female Correction Officer was attacked at Green Haven on 4/24. Multiple Officer injured while trying to restrain the inmate.
