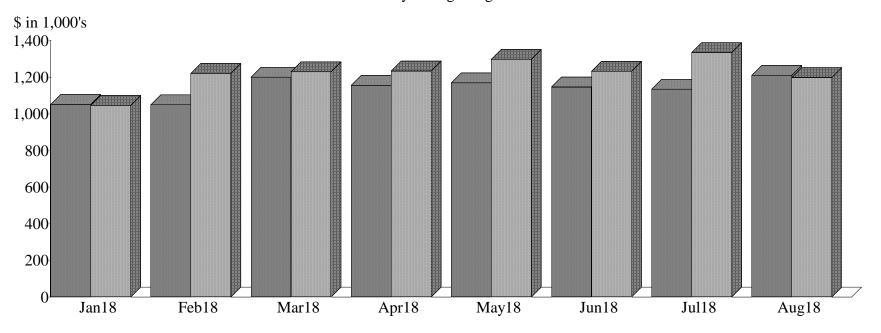

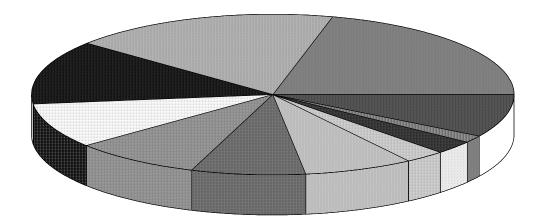

Income and Expense by Month January through August 2018



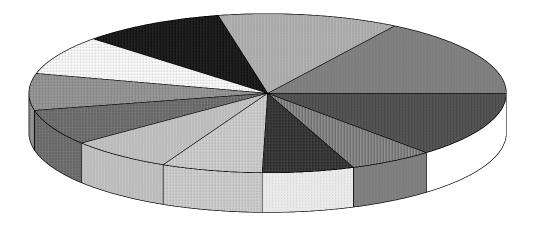
