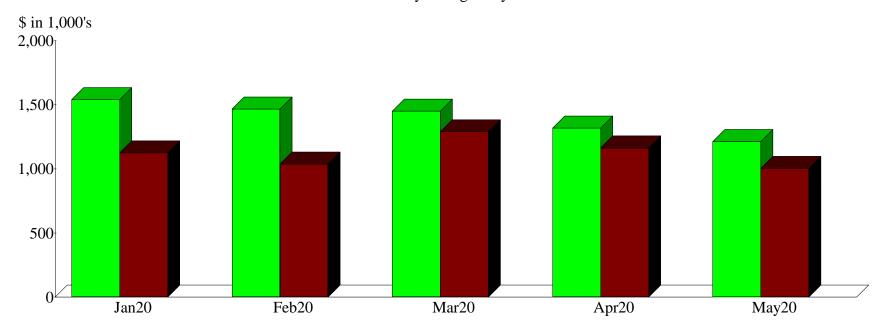

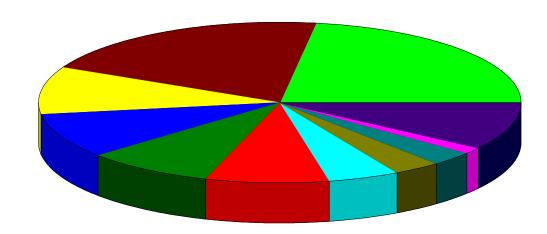

Income and Expense by Month January through May 2020



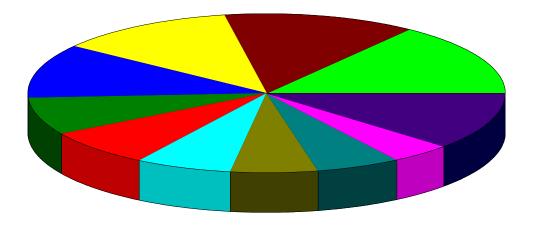
